Information about the collection and processing of your personal information

This Clinician Privacy Notice applies to you if you live in the EEA or the UK and perform a clinical role, such as a clinician or investigator, within one of Chinook's sponsored clinical trials. Where you provide SanReno with any personal information outside of this role, please see our website Privacy Policy (URL) <https://www.sanreno.com/privacy.aspx>.

SanReno Therapeutics (Shanghai) Limited ("**SanReno**") is a controller of your personal information and is headquartered in the People's Republic of China. SanReno is a clinical-stage biotech focused on kidney diseases and related therapeutic areas. SanReno partners with Chinook Therapeutics U.S., Inc. and Chinook Therapeutics, Inc. (collectively, "**Chinook**"). Chinook is a biopharmaceutical company headquartered in the United States. Chinook focuses on the discovery, development and commercialization of precision medicines for kidney diseases. Chinook acts as the sponsor of the relevant clinical trial study that you participate in (the "**Study**"). SanReno receives information about you as a result of your participation in the Study and because of our partnership with Chinook. More details about Chinook, the specific Study you participate in and Chinook's privacy practices as a separate controller of your personal information are set out in Chinook's Clinician Privacy Notice.

This Clinician Privacy Notice explains who we are, how we receive, share and use personal information about you, and how you can exercise your privacy rights. If you have any questions or concerns about our use of your personal information, or would like to exercise any of your rights, including to object to the processing of your personal information in the way that we describe here -- then please contact us using the details provided at the bottom of this notice.

What personal information does SanReno receive and why?

SanReno receives and uses the following categories of personal information for the purposes described below:

- Identity: surname, forename(s), sex, professional postal, electronic and telephone contact details, bank details;
- Education-diploma(s) including CV;
- Professional life (in particular professional background, mode and type of practice, publications, elements necessary for the evaluation of the knowledge you have to carry out the research);
- Where appropriate, identification number in the shared directory of healthcare professionals;
- Amount of allowances and remuneration received, information related to financial disclosures or other potential conflicts of interest;
- Collaboration in other studies; and
- History of access and connections to medical data of participants.

SanReno processes this information exclusively for the purpose of establishing and conducting the scientific research you take part in and for statistical analysis; potentially establishing a relationship with you, including to plan potential collaboration, contact, visits and meetings; for publication on www.clinicaltrials.gov and websites and databases that serve a comparable purpose; storage in databases to facilitate the selection of clinicians for future clinical trials or other business and to comply with our legal and regulatory obligations.

Who does SanReno share my personal information with?

We disclose your personal information to the following categories of recipients:

- to our **group companies, third party service providers and partners including clinical research organisations**, who provide data processing services to us, or who otherwise process personal information for purposes that are described in this document or notified to you when we collect your personal information. A list of our current group companies is available here SanReno Therapeutics (Hong Kong) Limited
- **auditors and insurers** for our clinical trials or research studies;
- **Independent ethics committees**;
- to any **competent law enforcement body, regulatory, government agency, court or other third party** where we believe disclosure is necessary (i) as a matter of applicable law or regulation, (ii) to exercise, establish or defend our legal rights, or (iii) to protect your vital interests or those of any other person;
- any potential buyer (and its agents and advisers) in connection with any proposed purchase, merger or acquisition of any part of SanReno's business, provided that SanReno informs the potential buyer it must use your personal information only for the purposes disclosed in this Clinician Privacy Notice; and
- to any other person with your consent to the disclosure.

Legal basis for processing personal information

SanReno's legal basis for collecting and using the personal information described above is its legitimate interest in potentially establishing a relationship with you, to assess your suitability to assist with sponsored clinical trials and research studies and for management and administration of the trials and studies. In addition, your personal information may be processed to comply with legal or regulatory requirements, including requirements to retain records in connection with clinical trials. How does SanReno keep my personal information secure?

SanReno uses appropriate technical and organisational measures to protect the personal information that it receives and processes about you. The measures SanReno uses are designed to provide a level of security appropriate to the risk of processing your personal information.

International data transfers

SanReno receives your data from Chinook in accordance with appropriate safeguards which requires your personal data to be protected in accordance with this Privacy Notice. This includes implementing the European Commission's Standard Contractual Clauses for transfers of personal data between Chinook and SanReno.

Your personal data is received by SanReno in the People's Republic of China and onward transferred to its group companies located in the Hong Kong SAR and around the world.

SanReno has implemented similar appropriate safeguards with its partners and third party service providers (such as SanReno's CRO service provider) and further details can be requested from legalh27y@sanreno.com.

Data retention

We retain personal information we receives where we have an ongoing legitimate business need or legal requirement to do so (for example, for the purpose of record keeping requirements in relation to clinical trials).

When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymise it.

Your data protection rights

You have the following data protection rights:

- If you wish to **access, correct, update or request deletion** of your personal information in accordance with applicable law, you can do so at any time by contacting us using the contact details provided under the "How to contact us" heading below.

- In addition, you can **object to processing** of your personal information, ask us to **restrict processing** of your personal information or **request portability** of your personal information. Again, you can exercise these rights by contacting us using the contact details provided under the “How to contact us” heading below.

We respond to all requests we receive from individuals wishing to exercise their data protection rights in accordance with applicable data protection laws. All the above rights can be exercised at any time with SanReno.
